
Sir,

In response to Your Application Dated **01 June 2019** you had applied for the post for **Assistant Professor** you were interviewed for the above post by Selection committee appointed by the Management under rules AICTE and State Government.

I am pleased to inform you that the Management has appointed you on said post in **Abasaheb Kakade College of B. Pharmacy Bodhegaon, Tal – Shevgaon Dist – Ahmednagar**. In the scale of Rs. **15600-39100** with effect from **01/02/2020** your appointment is subjected to the following terms and conditions

1. Your Services will be governed by the rules and regulation lay down by the AICTE and State Government from time to time.
2. a) You are appointed in clear vacancy on full time / part time basis on Probation for a Period of –
----- from the date of joining.
 b) Your appointment is purely temporary for a period of i.e. from **01/02/2020 To 31/05/2020**
 Your appointment is on the leave vacancy for the period form -----to -----.
 The post is reserved for ---- since you belong to the said category. You are appointed on full time basis on probation for a period of ----- Year from the date of joining.
 The post is reserved for ----- Since you do not belong to the said category, you are appointed full time of temporary basis against the reserved post for a period of ----- You shall not have any claim on the said post in future.
 This is temporary vacancy caused by ----- Hence you are appointed full – time on purely temporary basis for a period of ---- To-----
3. You will be paid basis pay of Rs. As per AICTE & State Govt. rules
Rules per month in the scale Indicated above. You will also be entitled to dearness allowance, House Rent Allowance and C.L.A.at the rates prescribed by the State Government from time to time. In case you are appointed for a period of more than one year, you shall earn annual increment.
ii) You will be paid remuneration at the rate of Rs. As per rule per lecturer / per hour.

- iii) Your appointment & Salary shall be subject to approval by the Maharashtra State Board of Technical education Mumbai and Director of Technical Education Maharashtra State as the case may be.
 4. Your appointment is subject to the minimum number 0 students and the work load prescribed of the post.
 5. You shall submit the original, as well as certificate, caste certificate, change of name certificate (if any) etc. Before joining your duties.
 6. In case you accept the appointment you shall have to execute Deed of contract of Service as prescribed in the statues at the time of joining the duties.
 7. You will be allowed to join the duties on producing of
 - i) Two passport size photographs.
 - ii) Character Certificate from two eminent persons, one of them should be Govt. Gazetted Officer.
 - iii) Discharge certificate from previous employer.(if any)
 8. You shall undergo medical examination by the approved medical officer the civil surgeon at the place of your duty, within three months from date of joining the duties. The appointment shall be provisional and conditional, pending submission of Medical certificate stating that you are free from and contagious disease and that you are physically fit for employment on the staff to the college.
 9. You are required to give the correct mailing address as soon as you join the duties and any change in the address given earlier should be communicated to the management. It will be presumed that any letter sent by Registered post.
 10. You will not conduct or engage yourself in any private tuitions or private coaching classes.
 11. You will not engage yourself in any other job paid – time, part – time of otherwise during the continuance of your service, without the permission of the complete authority / Management.
 12. Your services are transferable to any other colleges / Institutions run by the Management.
 13. Your appointment may be terminated, at any time by either side / party, by giving one months' notice or one month's pay in lieu of notice period in case the period spent in services is more than six months
 14. If you are found absent continuously for more than thirty – day without permission your services will stand terminated automatically. If you are found guilty dilatation of any terms and conditions mentioned above you will be liable of any terms and conditions mentioned above you will be liable for discipline action and punishment decided by the management as provide for in the statues. During the period of your service you shall not directly or indirectly do such things which are subversive the interests of society / DTE / Institute / College/ Students.
